

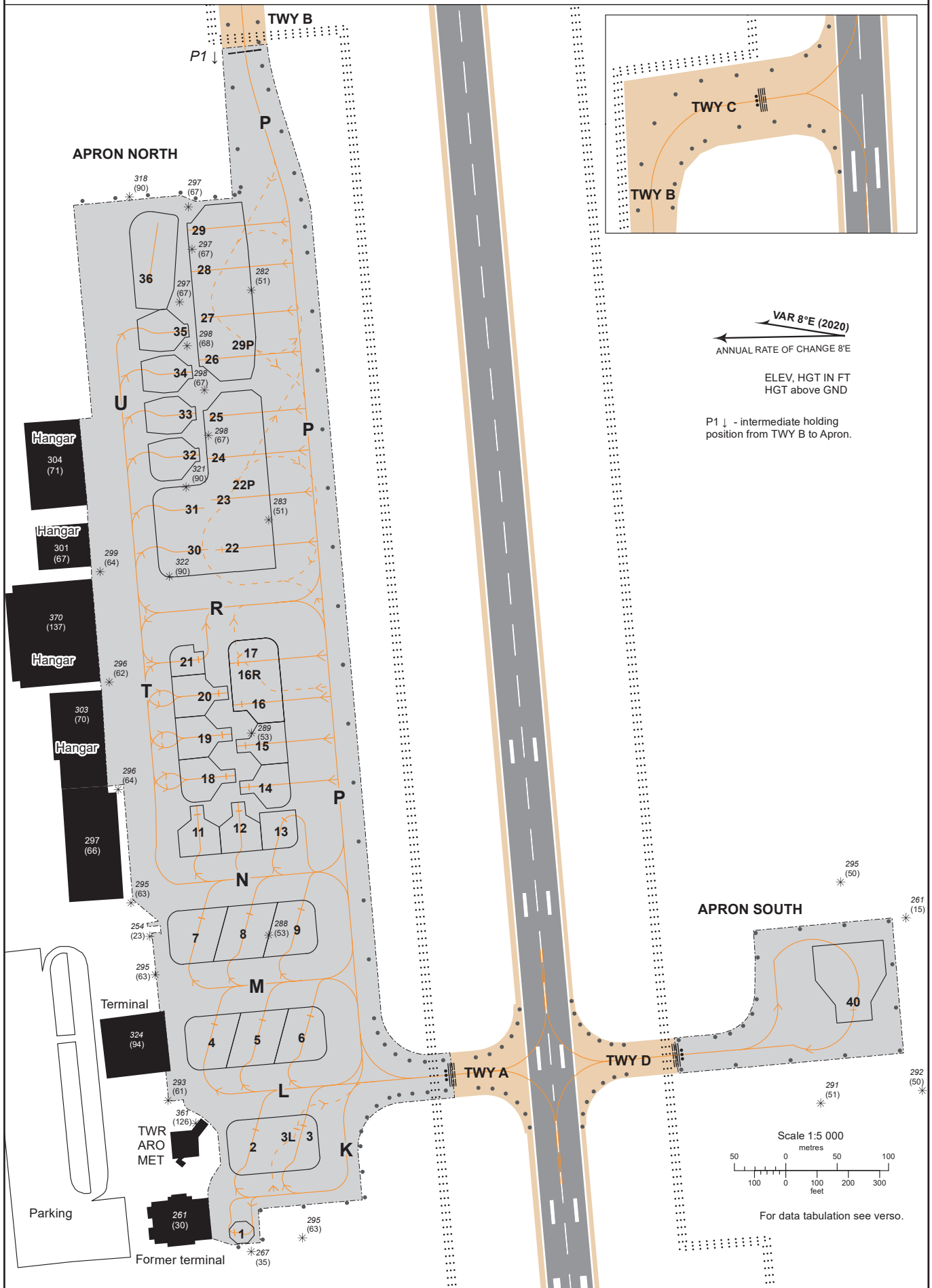

## Restrictions

K	Taxiing of CAT D and CAT E aircraft allowed only when parking stands 1, 2 and 3 are empty. Taxiing of CAT E aircraft allowed with "Follow-me" service only.
P	Taxiing of CAT D and CAT E aircraft allowed only when parking stands 6 and 9 are empty.
U	Movement to/from ACFT stand 36 is allowed only by push back tug.
